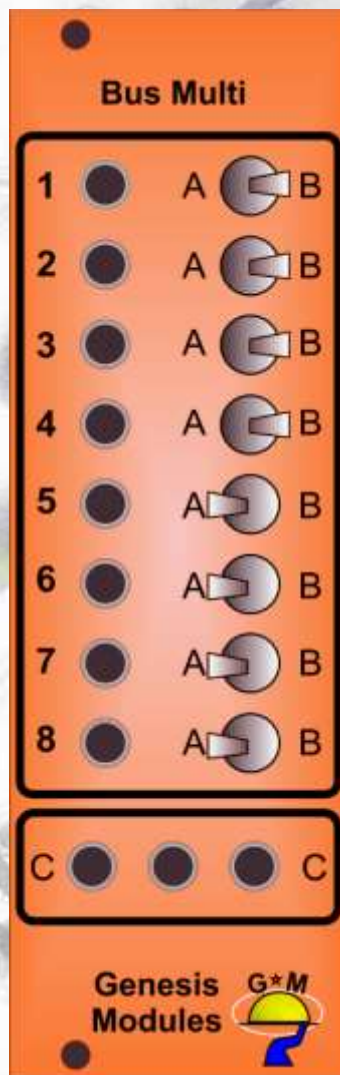

## Installation:

Your module is designed to be installed into a standard 3RU high Eurorack enclosure. Simply turn the power to your rack and unplug it from the power point to be safe when installing the module.

### **WARNING**

**Please ensure that the power to your rack is turned off and disconnected from power prior to installing your module.**

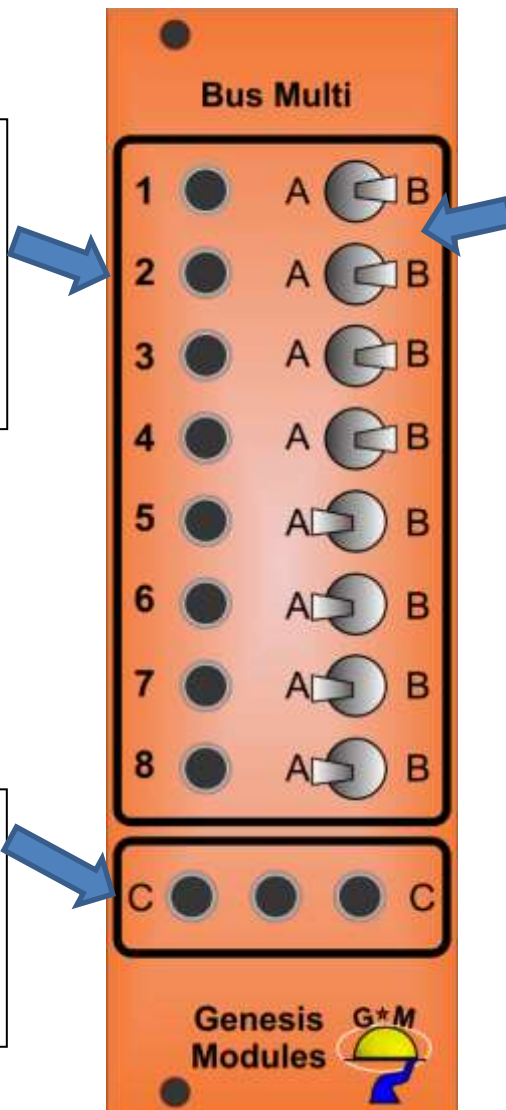


- Identify an unused space 8hp wide within your rack;
- Gently slide the module in between the mounting rails and install using the M6 x 10mm screws provided. Be careful not to overtighten the mounting screws.

This module does not require any power – it is totally passive.

## Module Controls:

Input / Output socket  
- 3.5mm Mono jacks  
to route signals into  
and out of the  
module.



Selection switches – Route the socket to either an 'A' or a 'B' bus.

In this example, the top four sockets are linked to each other through the 'B' bus and the bottom four sockets are connected to each other through the "A" bus

Fixed three channel bus allows one output to drive two inputs.

## Warranty:

### Australian Consumer Law Prescribed Statement

Our Products come with guarantees that cannot be excluded under the Australian Consumer Law (“ACL”). You are entitled to a replacement or refund for a major failure and for compensation for any other reasonably foreseeable loss or damage. You are also entitled to have the Products repaired or replaced if they fail to be of acceptable quality and the failure does not amount to a major failure.

### Warranty Terms

Notwithstanding Australian Consumer Law, Genesis Modules is proud to offer a Back to Base Warranty on our modules. We warrant that your module will be free from any defect in materials or workmanship for 12 months from the date of original sale.

This Warranty will not apply if any of the following events occurs in relation to your product during the applicable warranty period stated above:

- the module is modified or serviced by anyone other than an Authorised Service Agent;
- you use the module contrary to any recommended, technical, operating, handling or storage guidelines in this instruction manual;
- the module has malfunctioned as a result of: deliberate or accidental damage; neglect or modification; or the use of incorrect voltage or a power surge; or,
- The module is stored in a way that allows it to become damaged.

If you need to return the module under warranty, please contact us at [info@genesismodules.com](mailto:info@genesismodules.com) to obtain a RMA number. We will provide details on how to return the module to us for evaluation and repair. Genesis Modules is not responsible for damage that occurs during transport, so we strongly recommend that the module be returned in its original shipping container with insurance.

### Safety Note:

This module is designed to switch Eurorack compatible control voltage and signal levels. The maximum switch voltage rating is +- 35v DC at 100mA – It is not designed to switch power signals or mains level voltages. **Switching 110 / 230 / 240v mains voltages with this module would cause an extremely unsafe situation that may lead to death or equipment damage.**

## **California Proposition 65 Notice:**

**(Applicable to Californian residents only)**

**This product contains chemicals known to the State of California to cause cancer and/or birth defects or other reproductive harm.**

The State of California has a law called "Proposition 65", which is the California Safe Drinking Water and Toxic Enforcement Act of 1986. Any company that operates in California, sells products in California, or manufactures products that may be sold in or brought into California is subject to this law. Since our products are sold all over the world and may be shipped to California, Proposition 65 applies to us.

Proposition 65 requires a warning if a product contains any of 600-plus elements that the California Air Resources Board considers a carcinogen or a reproductive toxicant. These elements include lead (contained in the solder used to attach electronic parts to the printed circuit boards), brass, PVC and a multitude of other everyday elements.

Many of the elements listed under Proposition 65 are common everyday items. The list of elements keeps changing and is periodically updated. Elements are added to the list, some elements are removed. It is excessively difficult to keep track of the changing list of elements.

There are penalties for not complying with Proposition 65. Failure to label products may result in a civil penalty of \$2500 per day. If a company's product is sold or is purchased outside the State of California and brought into California, the company may still be found in violation.

Trade organizations have issued notices to manufacturers warning of Proposition 65 and its implications. Included in the warnings were suggested methods of protection from Proposition 65 litigation and violations. Protection requires warning consumers about the possibility of dangers from products. A warning such as the one we use is considered to comply with the requirement.

**The presence of this warning does not necessarily indicate our products will cause you to contract cancer or experience reproductive harm if used as designed.**

***We certainly recommend that you do not attempt to ingest the module!***
